ANTI-LOCK BRAKE SYSTEM LIGHT CAME ON. PROBLEM DIAGNOSED AS FAILURE OF KELSEY HAYES RWAL. THE DEALER QUOTED \$548 FOR THE PART AND \$87 LABOR. I DISCUSSED WITH THE DEALER AND DID FURTHER INVESTIGATION. THERE IS A HISTORY OF PROBLEMS WITH 1990-1995 GMC AND CHEVY 2-WHEEL SUBURBANS HAVING FAILURE OF THE ABS. I CONTACTED THE ZONE REP, WHO WAS NICE, BUT SAID NO RECALL CAMPAIGN TO-DATE MEANS NO REPLACEMENT BY GM. I AM DRIVING THE VEHICLE AS-IS (WITHOUT ANTI-LOCK) AND CONTINUING TO PURSURE HOW TO HAVE GM REPLACE THE DEFECTIVE KELSEY UNITS. \*AK
