IN OCTOBER OF 99' OUR CAR STOPPED RUNNING WHEN BRAKES APPLIED ON I75 DURING A CONSTRUCTION ZONE. IT THEN STOPPED RUNNING 5 MORE TIMES THAT DAY (10/02/99). WE TOOK THE VEHICLE IN TO FIND THE PROBLEM. BUT WE INFORMED THAT NOTHING SHOWED ON THE DIGINOSTICS. THIS HAS BEEN A REPEATED PROBLEM FOR 4 MONTHS. 2 OF THOSE MONTHS OUR CAR SAT AT FREEDOM DODGE OF LEXINGTON WITH PEOPLE TELLING US THE COULD NOT GET IT TO DUPLICATE. I HAVE PAID FOR PARTS THAT NEED NOT BE REPLACED, BECAUSE I WOULD GET THE CAR BACK AND ONCE AGAIN I WOULD GET ABOUT 2 MILES FROM WHERE I PICKED IT UP, AND IT WOULD STOP RUNNING ON ME. THIS HAPPENS WHEN I HIT THE BRAKES. I LOSE POWER STEERING AND POWER BRAKES. *AK
