ENGINE HEAD GASKET HAS FAILED, LEAKING LARGE AMOUNTS OF OIL INTO THE POSTERIOR PART OF THE ENGINE. THROUGH RESEARCH HAVE FOUND THIS IS A COMMON PROBLEM WITH THE NEON, AND AT TIMES HAS RESULTED IN ENGINE FIRES. THIS POSES A SIGNIFICANT SAFETY RISK AND I AM WONDERING WHY THERE HAS NOT BEEN A RECALL. I ALSO FEEL THAT CHRYSLER SHOULD BE HELD ACCOUNTABLE FOR THIS FAILURE AND NEEDS TO PAY FOR THE COST OF THE REPAIR. 'AK
