AS I DRIVE THE EXPLORER ON THE HIGHWAY OR AT ANY SPEEDS FOR LONGER PERIODS OF TIME(200+ MILES), ENGINE CHECK LIGHT COMES ON, AND THE HORSEPOWER IS AFFECTED. GAS MILEAGE DECREASES TO ABOUT 8 MPG, AND THIS LASTS FOR AS LONG AS THE VEHICLE IS DRIVEN. I HAVE HAD THE TRANSMISSION REPLACED, AND I HAVE CHANGED THE SPARK PLUGS, THE SPARK PLUG WIRES, THE MASS AIR-FLOW SENSOR, THE FUEL FILTERS AND THE ALTERNATOR. THE PROBLEM IS STILL OCCURRING THOUGH. I WOULD LIKE TO GET THE PROBLEM FIXED SO AS TO FEEL SAFE IN THIS VEHICLE. *AK
