THE TANK COULD BE COMPLETELY EMPTY AND IT WILL TAKE A DOLLAR'S WORTH OF GAS, THEN GAS WILL START SPEWING OUT ALL OVER. OUR CAR DEALER SAID HE DOESN'T KNOW WHAT IT COULD BE AND HASN'T HEARD ANYTHING FROM KIA ABOUT THIS BEING A PROBLEM. (IT ISN'T THE GAS GAUGE.) THE AIR BAG LIGHT CAME ON AND STAYED. WE GOT THIS FIXED AND HAVEN'T HAD PROBLEMS WITH THIS AGAIN. ALSO, WE HAVE A MANUEL TRANSMISSION. WE HAVE HAD TROUBLE WITH IT KICKING OUT OF GEAR. WE COULD BE GOING DOWN A HIGHWAY AND IT WILL KICK OUT OF FIFTH GEAR. IT DOES ITS OWN THING. WE HAVE HAD THIS VEHICLE SINCE AUGUST AND IT HAS BEEN NOTHING BUT PROBLEMS.
