I AM PROMPTED TO REPORT TO THE NHTSA AFTER READING ABOUT YOUR INVESTIGATION MENTIONED IN A MAGAZINE NAMED SPORT TRUCK OF JANUARY 2000, VOL 13, NO.1, PAGE 19 IN WHICH 1997 TO 1999 CK PICKUPS ETC; ARE SAID TO STEER UNEXPECTEDLY INTO OTHER LANES; CAUSING 4 CRASHES. JUST TO LET YOU KNOW, MY CANADIAN TRUCK AND MY INLAW,S TRUCK BOTH EXIBITED THIS STEERING PROBLEM. MY DEALER CHANGED OUT AFTER TESTING IT, S VOLTAGE RESISTANCE, THE EVO STEERING WHEEL POSITION SENSOR CORRECTING THE UNNERVING SENSATION OF OVERSTEER AT HIWAY SPEED IN A TURN. THIS SENSOR IS SAID TO CHANGE HYDRAULIC ASSIST OF THE STEERING DEPENDANT ON VEHICLE SPEED AND STEERING WHEEL POSITION TO EASE FOR PARKING. A DEFECT IN THIS SENSOR COULD CAUSE AN ANWANTED OVERSTEER EFFECT WHEN STEERING INPUT EFFORT IS
