CONDENSATION IN DISTRIBUTOR CAUSES SPATTERING. DEALER OFFERED \$1000 RETROFIT TO A VENTED DISTRIBUTOR. KNOWN BIG PROBLEM WITH OPTITRONIC IGNITION. GENERAL MOTORS REFUSED TO COVER UNDER WARRANTY.
