FUEL INJECTOR(S) ARE LEAKING RAW FUEL. THE MANUFACTURER PRESENTLY HAS A RECALL CAMPAIGN TO REPLACE LEAKING FUEL INJECTORS ON VARIOUS MAKES & MODELS UP TO 1988 MODEL YEAR. IT SEEMS TO ME TO BE A SIMILAR PROBLEM TO WHICH I AM EXPERIENCING ON MY VEHICLE. HOWEVER, THE MANUFACTURER'S REP. I SPOKE TO AT THE RECALL CAMPAIGN TELEPHONE NUMBER STATING MY VEHICLE WAS NOT PART OF THE PRESENT CAMPAIGN; I WOULD HAVE TO WAIT & HOPE FOR A POSSIBLE FUTURE RECALL CAMPAIGN ON MY VEHICLE. I AM WORRIED THAT CONDITION MAY BECOME WORSE UNTIL SUCH TIME AND POSE A POTENTIAL FIRE HAZARD. I AM EXTREMELY CONCERNED ABOUT THIS SINCE VEHICLE IS PARKED WITHIN AN ATTACHED GARAGE DIRECTLY UNDER MY CHILDREN'S BEDROOM. *AK
