ALL OF THESE PROBLEMS SEEM EXTENSIVE. AT THIS POINT, THE CAR IS AT THE DEALER WITH THE HEAD GASKET PROBLEM (AFTER PAYING \$118 WHEN IT FIRST OVERHEATED THE DAY AFTER PICKING THE CAR UP FROM OVERHEATING WHEN THE DEALER SAID THAT A THERMOSTAT WAS THE PROBLEM). DO WE HAVE ANY RECOURSE?
