TRUCK WOULD NOT RUN AT FULL POWER DUE TO THE IGNITION SWITCH LIGHTS WOULD ALSO FAIL ON THE DASH. KEY WOULD ALSO GET STUCK IN THE IGNITION DO TO A PROBLEM WITH THE IGNITION. THE EXHAUST PROBLEM WAS THE BAFFELS WERE BUSTED INSIDE THE MUFFLER. WINDSHIELD HAD A VOID BETWEEN THE UPPER FRAME AND THE WINDSHIELD CAUSING IT TO LEAK. BELT TENSIONER BROKE DURING A START UP. AIR CONDITIONER COMPRESSOR WENT OUT DURING MY TRAVEL HOME FROM WORK.AK
