SUDDEN ACCELERATION WITHOUT OPERATOR ACTION. IN OCTOBER '99, THE VEHICLE WAS ON THE HIGHWAY TRAVELING FORWARD WHEN IT BEGAN TO ACCELERATE. THE OPERATOR STEPPED ON THE BRAKES HARD FOR A WHILE AND THE ACCELERATION STOPPED. IN JANUARY '00 THE CAR WAS PARKED IN THE OPERATOR'S GARAGE. THE OPERATOR STARTED THE VEHICLE AND THEN THE RPM'S PICKED UP TO A LEVEL WAY ABOVE NORMAL FAST IDLE. THE OPERATOR NOTICED THAT THE ACCELERATOR PEDAL HAD NO RESISTANCE.
