I WAS DRIVING AT FREEWAY SPEED, WHEN I HEARD A "FLOP FLOP" LOUD NOISE. I PULLED TO THE RIGHT AND FOUND THAT THE TREAD WAS IN 1 LONG STRIP, STILL ATTACHED TO PART OF THE TIRE. THE TIRE WAS NOT COMPLETELY FLAT, BUT NOT DRIVEABLE. A LOCAL SHERIFF DEPUTY STOPPED TO HELP ME. HE THOUGHT THAT I HAD A "RE-TREAD" TIRE. I TOLD HIM THAT IT WAS THE ORIGINAL SPARE. HE TOLD ME TO CONTACT THE DEALER AND FIRESTONE. I DID. THEY SAID THEY COULDN'T HELP ME. THE DAMAGE TO MY SUV, WAS TO THE LEFT REAR FENDER, LEFT PASSENGER DOOR, AND TRIM. I HAVE SINCE REPLACED ALL TIRES AND KEPT 1 OF THE ORIGINAL FIRESTONE TIRES.*AK
