SIDE MIRRORS ARE DESIGNED IN SUCH A WAY THAT AN INDIVIDUAL WILL LOSE THEIR LIFE BEFORE THE MIRROR BREAKS FREE. I KNOW, MY DAUGHTER WAS KILLED BY THE PASSENGER SIDE MIRROR IN THIS WAY.
