THE PROBLEM STARTED WITH A THUMPING SOUND COMING FROM THE FRONT/BRAKE AREA OF THE VEHICLE. AFTER ATTEMPTING TO PULL OUT OF THE SHOPPING CENTER I REALIZED MY BRAKES WERE GONE. MY HUSBAND WAS ABLE TO GET IT TO RAPID MOTORS THE NEXT DAY AND WE WERE TOLD THAT THE MASTER CYLINDER WOULD HAVE TO BE REPLACED. JUST OVER 1 YEAR LATER THE SAME PROBLEMS STARTED AGAIN AND AGAIN THE BRAKES WENT OUT AND WE WERE TOLD AGAIN A NEW MASTER CYLINDER WOULD NEED REPLACING. EACH REPLACEMENT HAS COST US A LITTLE OVER \$300.00. I UNDERSTAND IT MAY BE TIME TO REPLACE BRAKE PADS BUT I DON'T THAT IS THE ONLY PROBLEM WITH THE MASTER CYLINDER NOT BEING ABLE TO LAST MORE THAN 1 YEAR. THE INVOICE FOR REPAIR OF THE LAST MASTER CYLINDER STATES: "FOUND BRAKE PEDAL GOES TO FLOOR, CHECK
