WITHIN A 2 MONTH PERIOD I HAVE EXPERIENCED 3 SEPARATE ELECTRICAL PROBLEMS. 1ST INCIDENT WAS A SURGING WHEN DEFROST WAS ON. DEALER REPLACED ALL SPARK PLUG WIRES AND SAID THAT IS WAS ARCING AND COULD HAVE CAUSED A FIRE OR WORSE. 2ND WAS THE GAS GAUGE WAS NOT WORKING. DEALER IS REPLACING FUEL SENDER. 3RD WAS 4X4 AND OVERDRIVE NOT WORKING. DEALER INITIALLY REPLACED BLOWN FUSE, BUT 2 DAYS LATER WAS BLOWN AGAIN AND DEALER IS CURRENTLY REPLACING "WIRING" IN STEERING COLUMN THAT WAS SHORTING. TRUCK IS CURRENTLY AT THE DEALERS.
