I WOULD LIKE TO KNOW IF THIS PIN THAT CAME LOOSE HAS BEEN A PROBLEM FOR ANY OTHER OWNERS. THE ENTIRE TRANSMISSION HAD TO BE REPLACED, AT A COST OF \$2000.00.
