WHILE TRAVELING WITH FRIENDS AND HORSES, AT HIGHWAY SPEEDS(65) THE FUEL GAUGE WAS SHOWING A LITTLE OVER A QUARTER AND THE TRIP COMPUTER WAS STILL SHOWING ABOUT 60 MILES TO EMPTY. THE TRUCK SPUTTERED AND ENGINE STALLED. IT WAS OUT OF FUEL. AFTER TRYING TO GET FORD ROADSIDE ASSISTANCE - WHO SAID WAIT 5-6 HRS TILL MORNING AND WE'LL GET SOMEONE OUT, AND AAA WHO DOESN'T TRANSPORT FUEL - ONLY GAS. THE NC HP WAS CONTACTED AND THEN TRANSPORTED TO TRUCK STOP AND BACK TO TRUCK WITH FUEL - THEN TRUCK RAN FINE. *AK
