THE ANIT-LOCK BRAKE LIGHT IS NOT ON, BUT SEVERAL TIME THE VEHICLE HAS GONE INTO A SKID WITH NO CONTROL. THE BRAKES LOCK AND UNLOCK AT A SLOW ENOUGH RATE TO CAUSE A HOPPING THAT DRIVER AND PASSENGERS CAN FEEL AND CAUSE A SKID. TOOK IN FOR SERVICE TOLD DRUMS AND ROTORS HAVE BEEN OVERTURNED, REPLACED STILL NOT WORKING PROPERLY. THE VEHICLE AND BRAKE PEDAL HOPS WHEN STOPPING NORMAL OR HARD.
