IT TOOK QUIT A WHILE TO OBTAIN THE PART NEEDED. THE DEALERSHIP WHERE I PURCHASED THE PART INFORMED ME THAT THIS WAS A PROBLEM FOR THE 92 MODEL AS WELL AS EITHER THE 91 OR 93 MODEL. MY MECHANIC BUILT A BRACE TO KEEP THE CRANKSHAFT PULLEY FROM FALLING OFF. THE DEALERSHIP CLAIMED NO RESPONSIBILITY AND I WAS TOLD THE PART HAD NOT BEEN RECALLED. *AK
