THE CAR'S BRAKE ROTORS WARP EVERY 1500 MILES RESULTING IN A LOSS OF BRAKING. THE ROTORS HAVE BEEN MACHINED AND/OR REPLACED ON 3 OCCASIONS BUT THE PROBLEM REOCCURS. WHEN BRAKING WITH THE WARPED ROTORS, THE ABS WHEEL SPEED SENSORS HIT THE "BAD" SPOT ON THE ROTORS AND ASSUME A LOCK-UP IS EMINENT. THE ABS SYSTEM THEN RELEASES PRESSURE ON THE BRAKES AND BRAKING DISTANCE EXCEEDS SAFE LEVELS. *AK
