I AM VERY AFRAID ONE DAY THE BRAKES WILL NOT WORK WHEN I NEED THEM TO. COULD YOU PLEASE FOLLOW UP WITH THE CHEVROLET COMPANY AND MYSELF ABOUT THIS PROBLEM. IT OCCURS TO OFTEN AND I HAVE HAD MECHANICS LOOK AT IT BUT THEY DO NOT KNOW WHAT THE PROBLEM IS. *AK
