THESE ARE THE LAST TWO OF THE SEVEN INCIDENTS OF TOTAL BRAKE FAILURE FOR THIS VEHICLE. ALL INCIDENTS OCCURRED AT SPEEDS OF 25 - 60 MPH. 6 OF THE 7 WERE DURING NORMAL STOPPING CONDITIONS; 1 EMERGENCY STOP. WHEN STEPPING ON THE BRAKE PEDAL THERE IS NO BRAKING ACTION. THE PEDAL DOES NOT GO TO THE FLOOR. STEPPING ON THE BRAKE PEDAL 1-2 MORE TIMES AND THE BRAKES THEN GRAB. 1 INCIDENT FAILED TO STOP AT A STOP SIGN; 1 NECCESITATED VEERING OUT OF LANE. *AK
