OIL LEAKAGE FROM HEAD GASKET WHICH COULD RESULT IN FIRE IN ENGINE COMPARTMENT. HEAD GASKET REPLACED AT OWNERS EXPENSE ON 24 NOV. 99. HEAD GASKET CONTINUES TO LEAK. SERVICE ADVISOR NOTIFIED ON 4 MAR.00. OWNER DOES NOT FEEL OBLIGATED TO PAY FOR 2ND REPAIR AND FEELS ENGINE HEAD GASKET SHOULD NOT HAVE NEEDED TO BE REPLACED AT ALL. VEHICLE IS ALMOST 4 YEARS OLD WITH LESS THAN 60000 MILES. LIFE AND LIMB ARE PUT AT RISK FOR VEHICLE OPERATOR AND PASSENGERS AND POTENTIALLY OTHER PERSONS D/T RISK FOR ENGINE COMPARTMENT FIRE FROM HEAD GASKET OIL LEAK.
