AIR CONDITIONAL HAS NOT COOLED PROPERLY SINCE WE BOUGHT VEHICLE, DURING SUMMER HOT MONTHS THE VEHICLE IS UNABLE TO KEEP THE INSIDE COOL AND COMFORTABLE. FIRST TRIP TO DEALERSHIP WAS 5 DAYS FROM TAKING OWNERSHIP, I HAVE BEEN TO 3 DEALERSHIPS OVER THE PAST 1 1/2 YRS AND NO ONE HAS BEEN ABLE TO FIX THIS. MOST SAY I'M CRAZY. BRAKES HAVE SQUEAKED CONSTANTLY NOT ONLY DURING MORNING HOURS. PAD HAVE BEEN REPLACED ONCE AT 9000 MILES AND DID NOT HELP AND NOW AT 29,000 MILES IT'S EXTREMELY LOUD PAD WERE CHECKED LAST WEEK AND STILL THEY SAY IT'S NORMAL. ENGINE IS PINGING ON ACCELERATION AND HAS SINCE WE BOUGHT VEHICLE, ONCE AGAIN DEALERSHIP IS SAYING THIS IS NORMAL WE HAVE TRIED HIGHER OCTANE FUEL AND ALSO MID TO SUPREME GAS AND IT STILL CONTINUES, I CAN ONLY GET RO
