IN CHECKING YOUR SITE I AM FINDING STISTEMIC PROBLEMS WITH THIS CAR AND LIKE CARS (IE DODGE INTREPID) ALSO FOR THE MODEL YEARS OF 1993,1994,1995. THE THREE MAJOR AREAS I FOUND ARE AIR CONDITIONING, STEERING/ LINKAGES, AND TRANSMISSION WHICH I HAVE THE SAME TYPE OF PROBLEMS WITH MY CAR. I HAVE REPORTED THE AIR CONDITIONER AND THE TRANSMISSION TO YOU A COUPLE OF DAYS AGO. *AK
