FORD REFUSED TO DO ANYTHING ABOUT THIS UNLESS I INCUR THE TOTAL EXPENSE AROUND \$500. - THIS IS A SAFETY ISSUE AS YOU HAVE NO WAY TO GAUGE YOUR SPEED. I ALSO HAVE A 92 TAURUS WITH THE SAME SPEEDOMETER HEAD, AND THAT ONE HAS FAILED TWICE TOO.
