RIGHT SIDE: BREAK PAD CLOSEST TO PISTON, HARDLY WORN, EXTERIOR PAD WORN BARE TO POINT WHERE ROTOR HAD TO BE REPLACED. LEFT FRONT: PAD CLOSEST TO PISTON HARDLY WORN. EXTERIOR PAD SEVERELY WORN. CALIPERS CHECKED ON LAST BREAK JOB AND APPEAR OK. MECHANIC EXPRESSED DISBELIEF AT SEEING SUCH UNEVEN WEAR ON PADS.
