REPLACEMENT OF INSTRUMENT CLUSTER ACTUALLY WORSENERD UNCOMMANDED LIGHT FLASHING. INITIAL REPAIR OF ENGINE PROBLEMS DIMINISHED SEVERITY OF STALLING, HOWEVER DID NOT COMPLETELY CORRECT THE PROBLEM.
