CAR ACCELERATES ALL ON ITS ON, INCLUDING GOING UPHILL WITHOUT EVEN TOUCHING THE GAS PEDAL CAR WILL TRAVEL BETWEEN 30 AND 40 MPH. WHEN PLACED IN PARK CAR RACES AT BETWEEN 3500 AND 4500 RPM'S AND HAS TO BE SHUT OFF. PLACING THE CAR IN NEUTRAL DOES NOT ELIMINATE THE PROBLEM. HAVE HAD CAR AT THE DEALER TWICE AND THEY COULDN'T FIND OR COULDN'T BE BOTHER TO FIND PROBLEM. REQUIRES EXCESSIVE BRAKE USE AND SOMETIMES STILL LURCHES FORWARD WITH FOUR WHEEL ANTILOCK BRAKES APPLIED. HAVE NOTIFIED FORD MOTOR COMPANY AND THEY SENT ME A QUESTIONNAIRE!!
