FRONT SUSPENSION ALMOST DRAGS ON ROAD SURFACE AND REAR SUSPENSION IS HIKED UPWARD, BLOCKING VIEW OUT OF REAR WINDOW. I HAVE TAKEN THIS PROBLEM TO TWO CHRYSLER DEALERS. ONE RECOMMENDED NOT TO FIX PROBLEM BUT TO GET RID OF CAR AND THE OTHER CHARGED \$38.69 FOR DIAGNOSTIC TEST AND TOLD ME THEY DID NOT KNOW WHAT THE PROBLEM IS. THIS IS A SAFETY PROBLEM WHICH COULD BE FATAL IF A HIGH SPOT IN THE ROADWAY IS HIT OR BY NOT BEING ABLE TO SEE SOUT OF THE REAR WINDOW WHEN CHANGING LANES INTO ON-COMING TRAFFIC. I FEEL THIS IS A SAFETY PROBLEM THAT CHRYSLER MUST OWN UP TO AND REPAIR AT THEIR EXPENSE.\*AK
