FAILURE RESULTED IN NO POWER ASSIST WHILE TURNING LEFT, BUT NORMAL POWER ASSIST WHILE TURNING RIGHT. DEALER COULD NOT IDENTIFY PRECISE FAILURE WITHIN SYSTEM. REPAIR MADE BY REPLACEMENT OF ENTIRE STEERING RACK. REPAIR COST WAS \$1,033. MANUFACTURER AND DEALER UNWILLING TO DISCUSS WARRANTY CONSIDERATION, CITING FACT THAT VEHICLE WAS 2 MONTHS AND 8,000 MILES BEYOND STANDARD WARRANTY PERIOD. *AK
