AS FOR THE DRIVER WINDOW, MANY OTHER GRAND AM OWNERS TELL ME THAT THEY HAVE SAME PROBLEM - THIS ONE HAS COST ME OVER \$100 IN DRYING OUT MY VEHICLE INTERIOR AND REPAIRS. *AK
