DETERIORATION OF THE INNER LINING OF THE FRONT BRAKE LINES CAUSED THE BRAKES TO LOCKUP AFTER APPLYING. THE LEFT FRONT BRAKE WAS THE ONLY PROBLEM AND WHEN IT WOULD LOCKUP IT CAUSED THE VEHICLE TO PULL SEVERLY TO THE LEFT. THE FIRST TIME THE BRAKE LOCKED UP IT CAUSED THE VEHICLE TO SWERVE INTO THE ON COMING TRAFFIC. *AK
