THE NISSAN MECHANIC SAYS HE FIXES THIS ALL THE TIME- THEY ARE GOUGING CUSTOMERS FOR A FAULTY PART WITH AN EXTREMELY HIGH FAILURE RATE. I THINK THEY SHOULD DO IT AT N/C OTHERWISE I'M NOT BUYING ANYMORE NISSANS. I DON'T KNOW IF IT'S SAFE TO DRIVE AROUND WITH THE ENGINE SOUNDING LIKE IT'S FALLING APART.
