LATEST RESULT - PER DEALER "WE CAN'T FIX BECAUSE IT HAPPENS WITH SPEEDS OVER 65MPH AND TOYOTA WILL NOT AUTHORIZE REPAIRS ON ISSUES OCCURRING OVER 65 MPH. ALSO, BRAKES MAKE BAD GRINDING NOISE AND SQUEEKS FORWARD/REVERSE - ADVISED IT IS BECUASE OF THE MATERIAL OF THE PADS.
