UNINTENDED ACCELERATION. VEHICLE GOING ~50 MPH ON TWO-LANE ROAD. ACCELERATED RAPIDLY TO PASS ANOTHER VEHICLE. PASSED AT ~65 MPH. TOOK FOOT OFF ACCELERATOR BUT VEHICLE CONTINUED TO ACCELERATE. WAS ABLE TO BRING TO A STOP. IN 'PARK' ENGINE ALSO RACED. LINKAGES CHECKED, BUT WERE OK. VEHICLE BROUGHT TO TOYOTA DEALER IN FLAGSTAFF AZ. THEY COULD NOT FIND PROBLEM. OWNER CONTACTED TOYOTA TWICE.
