ABS BRAKES FAILED IN DRY, SUNNY WEATHER IN SCHOOL ZONE AT 3 PM WHEN KIDS WERE COMING OUT OF SCHOOL. COULD NOT TURN VEHICLE ONTO SIDEWALK BECAUSE OF CHILDREN AND HIT STOPPED VEHICLE DESPITE A 200 FT STOPPING DISTANCE AT 25 MPH. ABS BRAKES DID NOT SLOW VEHICLE AT ALL. FORD CLAIMS NO ABS BRAKE DEFECT.
