WHILE MAKING A ROUTINE RT TURN, THE GEAR ASSEMBLY OF THE RACK AND PINION ASSEMBLY "BLEW-OUT". THIS EVENT LOCKED MY STEERING UP. NO WARRANTY IN PLACE TO RECOVER LOSS. BUT, THE NATURE OF THE EVENT WAS UNUSUAL. THAT IS, THE MECHANICAL FAILURE OF THE GEAR(S) FRACTURING AND EXPLODING IT'S HOUSING CAUSING LOSS OF STEERING IS HIGHLY QUESTIONABLE? AT A HIGHER SPEED THIS WOULD HAVE CAUSE INJURY OR LOSS OF LIFE. A CERTIFIED MECHANIC WITH 20+ YEARS EXPERIENCED INDICATED THAT HE HAS NEVER SEEN A RACK AND PINION ASSEMBLY "BLOW-OUT" LIKE THE ONE I AM PRESENTING IN THIS CASE. THE SUPERVISOR MECHANIC FURTHER INDICATED, "THAT THIS COULD HAVE CAUSED A SERIOUS ACCIDENT". I HAVE THE RACK AND PINION ASSEMBLY IN MY POSSESSION AND I HAVE ALSO CONTACTED GENERAL MOTORS CU
