THE FRONT BRAKES ON THIS TRUCK FAILED TO WORK EVENLY. A SEVER PULL TO THE LEFT, RESULTING IN A NEAR JACK KNIFE SITUATION AND COLLISION WITH ON COMING TRAFFIC. I IMMEDIATELY TOOK THE TRUCK INTO THE DEALER. THEY HAVE BEEN UNSUCCESSFUL IN REPAIRING IT AND STATE THAT ONLY 5% OF THE TRUCKS IN THIS MODEL DO THAT, THEREFORE DODGE WILL NOT RECALL AND THE WARRANTY WILL NOT COVER THE REPAIRS.
