JUST BECAUSE THE STICKER SAYS MY VAN WAS MFG. IN 96 DOES NOT MEAN THAT THE ENGINE COULD NOT HAVE BEEN MFG AT THE SAME TIME AS A THE ENGINE FOR 94 OR 95 VAN. THEY ARE OFFERING MONEY FOR TRADE-IN OR ENGINE REPLACEMENT. IT SEEMS VERY COINCIDENTAL THAT THEY JUST ANNOUNCED THIS PROBLEM ON 94-95 VANS AND MY 96 HAS THIS PROBLEM. *AK
