NARRATIVE DESCRIPTION OF FAILURE(S), INCIDENT(S), INJURY(IES)

I HAVE HAD BOTH PROBLEMS (ABS AND TIRE FAILURE) ON TWO SEPERATE OCCASIONS. THE DATE ON THE REPORT WAS FOR THE MOST RECENT. I CAME AROUND A CURVE TO THE RIGHT, THEN TURNED TO THE LEFT TO STRAIGHTEN OUT FOR THE ROAD AND NOTHING HAPPENED. I STARTED HEADING FOR A DITCH IN SOMEONE'S YARD SO I APPLIED THE BRAKES THEY LOCKED UP THEN RELEASED COMPLETELY. MY RIGHT FRONT TIRE WENT FLAT CAUSING STEERING TO BE NONRESPONSIVE. IN MY FIRST ACCIDENT, I WAS FOLLOWING A FRIEND COMING FROM A LIGHT THAT JUST TURNED GREEN, AND THE CAR IN FRONT OF HIM STARTED TO SLOW DOWN TO TURN, WHEN I APPLIED THE BRAKES, THEY LOCKED UP AND WOULD NOT RELEASE SO I TURNED THE WHEEL TO AVOID THE ACCIDENT AND THE RIGHT FRONT TIRE WENT FLAT CAUSING ME TO SLIDE ON THE WHEEL INTO THE BACK OF ANOTHE
