I ENTERED MY VEHICLE AND WHEN I SAT IN THE DRIVER'S SEAT THE FRONT LEFT FRAME BRACKET ON THE SEAT SNAPPED. THE WELDING APPARENTLY BROKE. THIS VEHICLE HAS NEVER BEEN OFF-ROAD AND I AM NOT OBESE. NOW, WHEN I SIT IN THE SEAT, IT LEANS BACK IN AN UNCOMFORTABLE AND, MOST IMPORTANTLY, DANGEROUS POSITION. THE SEAT MOVES BACK AND FORTH EVERYTIME THE ACCELERATOR AND/OR BRAKE PEDAL IS DEPRESSED. I TRIED TO HAVE GM FIX THIS, BECAUSE IT IS OBVIOUSLY A DEFECT, AS WELDING SHOULD NOT COME UNDONE UNDER NORMAL OPERATING CONDITIONS. GM WOULD NOT ACCEPT THE RESPONSIBILITY TO FIX THIS DEFECT. \*AK
