AT APPROX. 4800 MILES NOTICED WHEEL VIBRATION WHEN BRAKING AT HIGHWAY SPEEDS. TOOK IN TO DEALER AND THEY SAID THEY FOUND NOTHING. VIBRATION PROCEEDED TO GET SEVERE AND TOOK VEHICLE IN AGAIN AT 7400 MILES. THEY RESURFACED ROTORS WHICH FIXED THE PROBLEM. NOW AT 10600 MILES AGAIN GETTING VIBRATION WHICH IS CONTINUING TO GET WORSE AS VEHICLE IS DRIVEN. WHEN VEHICLE WAS TAKEN IN AT 7400 MILES I FEEL IF LEFT TO CONTINUE THE VIBRATION WAS SOON TO GET SEVERE ENOUGH TO LOOSE CONTROL OF VEHICLE. *AK
