THE EVAPORATOR COIL IS PRONE TO PREMATURE FAILURE. I WORK FOR A COMPANY THAT OWNS 25 TO 30 DODGE CARAVANS OF VARIOUS YEARS AND THIS IS A COMMON PROBLEM ON MODELS BUILT BETWEEN 1993 AND 1999. ALSO THE DEALERSHIP HAS ADMITTED TO ME THAT THEY HAVE REPAIRED 100'S OF VEHICLES (CHRYSLER/DODGE/PLYMOUTH) WITH THIS TYPE OF PROBLEM. DAIMLER CHRYSLER'S CUSTOMER ASSISTANCE HOT LINE OFFERED NO HELP WHATSOEVER. WHEN THE REFRIGERANT (R134A) LEAKS, IT ENTERS THE PASSENGER COMPARTMENT AND CAN BE TOXIC IF COMBUSTED, NOT TO MENTION NOT A GOOD THING TO BREATHE NON-COMBUSTED. *AK
