THE HEAD GASKET FAILED AS NOTED AND I WAS NEVER INFORMED THAT CHRYSLER WILL REIMBURSE THE OWNER FOR REPAIRS SINCE THIS IS A WIDESPREAD PROBLEM. THE TOTAL COST WAS \$641.70 AND THE WORK WAS DONE THROUGH AN AUTHORIZED DEALER. SUPPOSEDLY, CHRYSLER HAS EXTENDED THE WARRANTY TO UP TO 5 YEARS/100,000 MILES OWNERS WILL BE REIMBURSED FOR PREVIOUS ENGINE REPAIRS. UNFORTUNATELY, THERE IS NO WRITTEN RECORD OF THIS SECRET WARRANTY. *AK
