UPON INVESTIGATION OF AN OIL LEAK UNDER THE HOOD OF MY 1998 DODGE NEON I WAS INFORMED THAT THE PROBLEM WAS A DEFECTIVE HEAD GASKET AND SENDING UNIT. WHEN I CALLED THE LOCAL DODGE DEALERSHIP, MARIETTA DODGE, INC., 701 COBB PARKWAY SOUTH, MARIETTA, GA 30062, (770-424-6601) I WAS TOLD THAT THIS WAS A COMMON PROBLEM AND SINCE MY AUTO WAS NOT OVER 80,000 MILES THE PART WOULD BE REPLACED. HOWEVER, WHEN I ARRIVED FOR SERVICE I WAS TOLD THAT THE 36,000 MILE WARRANTY WAS EXPIRED SO THE PART COULD NOT BE REPLACED FREE OF CHARGE. I FEEL THAT THE PART IS A MANUFACTURE DEFECT AND SHOULD BE COVERED REGARDLESS OF THE 36,000 MILE WARRANTY, ESPECIALLY SINCE IT DID NOT SHOW UP UNTIL THAT PARTICULAR WARRANTY WAS ALREADY EXPIRED. I SEE THAT THIS PROBLEM HAS BEEN ADDRESSED
