I REPLACED WINDSHIELD WIPER MOTOR AT MY OWN EXPENSE/ CIRCUIT BOARD DID NOT COME WITH NEW MOTOR AND HAD TO BE TRANSFERRED FROM OLD UNIT. THIS WAS COVERED UNDER A RECALL NHTSA 98V15001 HOWEVER IT COVERED VEHICLES MFG. UP TO 5/96 MINE WAS MFG 6/96 YET IT HAS THE PROBLEM COVERED IN THE RECALL WHICH IS TO CORRECT AN INTERMITTENT WIPER FAILURE. IT'S A REAL TREET TO BE DRIVING DOWN THE INTERSTATE AND HAVE YOUR WIPERS QUIT. YOU CAN PULL OVER, OPEN THE HOOD, AND SLAP THE WIPER UNIT AND IT WILL RESUME WORKING FOR A WHILE. .
