1. WHEN I DROVE @ THE SPEED OF 55, THE WHEEL STILL SHIFT TO THE RIGHT. 2. ELLIS BROOKS(DEALER) REPLACED THE NEW CABLE ON 01/2000, TWO WEEKS LATER I WENT ON VACATION FOR 5 WEEKS, THE CAR HAVEN'T DRIVE THEN. ABOUT 2 WEEKS AFTER I CAME BACK FROM VACATION, I START TO FEEL THE CLUTCH LOOSE AGAIN. THEN ABOUT 3 WEEKS LATER THE CLUTCH CABLE HAD BROKEN AGAIN. FROM THERE I CHANGED NEW CLUTCH(DEALER SUGGEST TO REPLACE CLUTCH), BUT NOW THE CAR STILL IN THE DEALER GARAGE WAITING FOR THE CABLE, IT IS BEEN 3 WEEKS. THE DEALER AND MANUFACTURE CLAIM CAN'T FIND THE NEW CLUTCH CABLE YET. AND THEY DON'T WANT TO PROVIDE CAR RENTAL.
