UPON OPENING DOOR AT STOP, RESTRAINTS FAIL TO DISENGAGE TRAPPING OCCUPANT UNTIL MANUALLY DISCONNECTED. RECALL AT DEALER FAILED TO YIELD VIN MATCH. ALSO TOLD VEHICLE TOO OLD TO REPAIR. PROBLEM EXISTS ANYWAY, DUE TO SAME MANUFACTURER DEFECT AS IN CAMPAIGN 88V06300. CAN CAUSE INJURY TO OCUCPANTS. ^AK
