THE SERPENTINE BELT TENSIONER IS AN ITEM REQUIRING NO MAINTENANCE. WHEN IT FAILS THE VEHICLE IS COMPLETELY DISABLED. THE TRANSMISSION COOLING LINE FAILED WHERE IT CONNECTS TO THE TRANSMISSION. THIS CONNECTION POINT IS DIRECTLY ABOVE THE EXHAUST SYSTEM SO WHEN IT FAILS TRANSMISSION OIL IS SPEWED ALL OVER THE HOT EXHAUST PIPES/CATALYTIC CONVERTER.
